Dear Leader McConnell, Speaker Ryan, Leader Schumer, and Leader Pelosi:

On behalf of the University of California, I write today to express my deep concern and profound disagreement with President Trump's decision to effectively end the Deferred Action for Childhood Arrivals (DACA) program. I urge Congress to immediately take up and pass bi-partisan legislation that will protect our nation's Dreamers and provide them with the opportunity to continue to live, work and contribute to the only country they have ever known.

Without Congressional action, the President's decision to effectively end DACA will derail the lives of an estimated 800,000 Dreamers who were brought to the United States as children, developed deep roots in the country, and have become valuable contributors to their communities. DACA recipients must currently attend school, have graduated high school or successfully obtained a general education development certificate, or be an honorably discharged veteran, among other requirements, and they cannot have been convicted of a felony or a major misdemeanor.

Dreamers pay taxes and they live and work in our communities as paramedics, teachers, and entrepreneurs; they purchase homes and automobiles and otherwise contribute to the national and their local economies. They have been subject to exhaustive background investigations to ensure they are not a security threat. They have called no country but the United States home.


